

Proposed Tallest Building to be Net Zero – in Iraq http://listman.ashrae.org/t/5695722/36010494/13443/30/

BASRA, Iraq—Iraq's Basra Province is planning to build a 1,152 m (3,780 ft) skyscraper, which will be taller than Dubai's 829.8 m (2,722 ft) Burj Khalifa, currently the tallest building in the world, and the under-construction 1 km (3,280 ft) Kingdom Tower in Jeddah, Saudi Arabia. The 230-story Bride Tower, proposed by AMBS Architects, will consist of four conjoined towers. AMBS intends to make the project net zero energy. According to AMBS, because temperatures consistently reach 43°C (110°F) during summers in Basra, the surplus of solar energy in the region make it a prime candidate to successfully implement such a design. The proposed structure will be covered by a glazed canopy on its south facade that resembles a veil. It is designed to provide shade to the project's low-rise buildings and public areas. The three other towers within the project are set to be 724 m (2,375 ft), 484 m (1,588 ft) and 61 m (200 ft). EERE Network News (www.Energy.gov):

Energy Department Launches New Initiative to Help Cities, States Advance Building Efficiency

The Energy Department on November 9 announced the launch of the SEED Collaborative, a strategic effort to help cities and states manage building energy performance data and identify opportunities for efficiency improvements in their jurisdictions. Through a three-year partnership, a select group of cities and states will receive technical assistance, participate in peer exchange, and provide input on future development of the Energy Department's Standard Energy Efficiency Data (SEED) Platform, a resource in the Better Buildings toolkit. Participants will be announced early next year.

This will help reduce the time, cost, and resources needed to manage data from different sources across diverse portfolios of buildings. See the Energy Department news release and the SEED Web page.

AEE Newsletter:

Manufacturers in Energy Department's Better Plants Program Save More than \$2 Billion in Energy Costs

The U.S. Department of Energy announced that manufacturers in its Better Buildings, Better Plants Program (Better Plants) have racked up an estimated \$2.4 billion in cumulative energy cost

savings over the last five years. Across America, manufacturers spend more than \$200 billion each year to power their plants. As part of the Obama Administration's efforts to double energy productivity, American manufacturers and water and wastewater treatment agencies made a voluntary commitment to improve energy intensity by about 25 percent over ten years, or an equally ambitious level for their sector, through the Better Plants Program.
